# **Communal Violence-2023 And Jamiat relief operation**

n Monday, July 31, 2023, a wave of communal violence erupted in the town of Nuh region in Haryana stemming from what was ostensibly a religious procession known as the Jal Abhishek Yatra, organized by the Vishwa Hindu Parishad (VHP) and Bajrang Dal. As evening fell, the unrest escalated, and numerous distressing incidents of communal violence unfolded in Gurugram and Sohna. Tragically, this unrest subsequently spread to Mewat and its neighboring region. Amidst this sectarian strife, seven lives were tragically lost, dozens sustained injuries, and property valued at millions was ravaged by an enraged mob. Miscreants also damaged 13 mosques and one dargah. According to a report by the online publication thewire. in, the violence's catalyst was a video featuring the infamous cow vigilante, Monu Manesar. In the video, he rallied his followers to partake in the Hindutva rally taking place in the Noh district, known as the "Brijmondal" Yatra. These Yatras, organized by VHP leaders on a significant scale since 2021, had become commonplace. Manesar asserted his intention to personally attend the rally.

## Mewat Unrest and Humanitarian Initiatives by Jamiat Ulama-i-HindA letter to Chief Minister

#### New Delhi, August 10, 2023:

On August 1, Maulana Mahmood Asa'd Madani, President of Jamiat Ulama-i-Hind, expressed deep concern regarding the provocative rally orchestrated by sectarian groups in Nuh and the ensuing communal riots. He addressed a letter to Chief Minister Manohar Lal Khattar, urging prompt action against both the culpable police officers and those responsible for instigating the unrest.Jamiat delegation Amid the widespread panic prevailing in Mewat and the blockaded roads, the President of Jamiat Ulama-i-Hind convened a meeting at the organization's office. He issued instructions for a delegation to promptly journey to Mewat and provide extensive assistance to the affected people. Thus, on the afternoon of August 1st, the Jamiat Ulama-i-Hind delegation, led by Maulana Hakeemuddin Qasmi set forth. Their initial visit was Gurugram Sector 12's mortuary, where they offered condolences to the grieving family of martyr Imam Hafiz Muhammad Saad. Jamiat

consoled the bereaved, facilitated the transport of the martyr's body to his native place Sitamarhi, and arranged for the support of his family. Meanwhile, the delegation also engaged with local police officers, asserting its readiness for collaboration in restoring peace, alongside the local units of Jamiat Ulama-i-Hind.Formation of administer relief efforts, while a legal cell was instituted to pursue legal avenues. After a detailed and careful scrutiny, with certain modifications and changes, Jamiat's response was submitted to the Law Commission of India. The Majlis-e-Amila also made the decision to meet with the President of India on this issue and agreed to write a letter to all state chief ministers and party leaders informing them of the unanimity of the Muslim community's position on the Uniform Civil Code. Additionally, it was decided that both, Muslim and non-Muslim lawmakers from various political parties should be engaged with and encouraged to speak out against the UCC's negative effects in the forthcoming parliament session.

### Jamiat's response to the Law Commission of India on the

- 1. The rights of individuals and religious denominations under *Articles 25* and 26 respectively shall be affected;
- **2.**The diversity of the country (which is basic feature of our social structure) shall be affected and this will seriously impact the *national integration* of our country.
- **3.**The *federal structure* and allocated legislative powers of different legislatures of our country, where States and the Centre are free to make laws in their respective areas; shall be seriously affected.
- **4.**A mandatory uniform code on family-matrimonial laws shall be preposterous to our nation governed by the principles of *secularism*, a basic feature of the India Constitution and unique to the Indian subcontinent, a nation where existing codes on criminal and civil law are not uniform to begin with and are embedded with inclusive and secular principles based on diversity of the nation.
- 5.A mandatory uniform code shall be a blanket imposition of one's

identity in a country whose inhabitants possessdiverse identities.

- **6.**A uniform code on family laws shall severely impact the *cultural rights* protected under the fundamental rights.
- **7.**A mandatory uniform code shall be an affront to the cherished principle of *legal pluralism*. A uniform code shall push our country many steps back from inclusivity and tolerance.
- **8.**Under the Muslim Personal Law (*Shariat*), the burden of maintenance of entire family is upon the husband/father. A code based on strict interpretation of 'equality' shall mean the burden of maintenance to be shared by the wife/mother equally.
- **9.**Under the Muslim Personal Law (*Shariat*), the entire income/earnings and property of the woman is exclusively owned by her, not shared by the husband or the children whether during subsistence of marriage or after divorce. A code based on strict interpretation of 'equality' shall mean denial of exclusive ownership to her.



- **10.**Under the Muslim Personal Law (*Shariat*), in the event of divorce or death of the husband, the burden of maintenance of the children shifts to the father (divorced husband), paternal grandfather, paternal uncles or sons until the children attain adulthood. A code based on strict interpretation of 'equality' shall mean a system where a woman, divorced or widowed, shall have to bear the burden of maintenance.
- **11.**Under the Muslim Personal Law (*Shariat*), a woman receives maintenance during her *iddat* period. As per Section 125 CrPC, a woman is eligible for such a maintenance until she gets married again. Our courts have recently opined that even a woman who is employed can seek maintenance from her husband. A code based on strict interpretation of 'equality' shall mean either women loose the right of being maintained by their husbands or an equal burden of maintenance on a socio-economically disadvantaged class of women.
- **12.**Under the Muslim Personal Law (*Shariat*), a man pays dower or *mahar* at the time of marriage. A code based on strict interpretation of

'equality' shall either mean women being forced to forego their dowers or being coerced to pay dowers to men. Needless to mention, the shift in the law of dower will impact the contractual nature of a Muslim marriage.

- **13.**The inheritance law of *Shariat* is based on the principles of equity rather than equality *strictosensu*. Accordingly, since Muslim men have been tasked with the financial responsibilities of maintaining a family, their rights in property have been placed on a higher pedestal in terms of their higher financial responsibilities.
- 14.Under the Muslim Personal Law, one cannot transfer his property by Will in favour of any of the legal heirs whether man or woman. A Will, further, is not permitted of more than one-third part of a testator's property. Under the codified applicable Hindu law, the distribution of the entire property in favour of one's sons - disadvantaging Hindu women - has remained a social predicament.

#### New Delhi, 14th July 2023:

In response to the call given by Jamiat Ulama-i-Hind, a nationwide "Yaum-e Dua" (special prayers day) was observed all across the country on the occasion of Friday prayers "in the context of the proposed

Uniform Civil Code, on 14<sup>th</sup> July. After the Friday prayers, lakhs of people also sent their responses to the Law Commission of India using the barcode provided by the Jamiat.

In his opening address, Maulana MahmoodAsa'd Madani emphasized that the implementation of a uniform civil code might jeopardize the constitutional principles of religious diversity, minority rights, equality and justice. He stressed the importance of preserving India's rich cultural and religious diversity while safeguarding the religious rights delivered a comprehensive analysis through a Power Point Presentation, shedding light on the possible pitfalls of the Uniform Civil Code. He specifically highlighted the potential adverse effects on Muslim women, illustrating how the proposed code could alter certain rights prescribed by the Muslim Personal Law (Sharia Act). He pointed out that the current Muslim Personal Law Act places the burden of supporting the entire family on the husband or father, whereas the UCC, based on the notion of so called equality, would distribute the burden of maintenance equally between the husband and wife. Additionally, under the UCC, Muslim women would lose certain rights to property, such as mahar, inheritance, and

## **Jamiat Ulama-i-Hind Calls for Ban** on Defamatory Movie, Ajmer-92




# JUH Leadership Training Center in Kerala

### The stance of Jamiat Ulama-i-Hind on Qadyani community

#### New Delhi July 25, 2023

Jamiat Ulama-i-Hind has supported the stance taken by the Andhra Pradesh Waqf Board regarding the Qadianis, asserting that it reflects the unanimous position of the entire Muslims. Union Minister SmritiIrani's insistence on a different view is deemed unwarranted and illogical since the Waqf Board's primary purpose is to safeguard the endowments and interests of Muslims, as defined in the Waqf Act. Therefore, properties and places of worship belonging to a community that is not recognized as Muslim do not fall under the jurisdiction of the Waqf Board. This position was established by the Andhra Pradesh Waqf Board in 2009, following the representation made by Jamiat Ulama Andhra Pradesh. Recently, the incumbent Waqf Board reiterated the same stance in its statement in February 23.

The religion of Islam rests on two fundamental beliefs: Tawheed, affirming the oneness of Allah and the belief that Prophet Muhammad (peace and blessings of Allah be upon him) is the final Messenger of Allah. Both of these beliefs are integral components of the five basic pillars of Islam.

Contrary to these essential Islamic beliefs, MirzaGhulam Ahmad Qadiani took a position that challenges the concept of the finality of Prophethood. In light of this principled and factual difference, there is no basis to consider Qadianism as an Islamic sect, and all Islamic schools of thought agree that this group is non-Muslim.

The reputed Islamic organization "World Muslim League" reached a consensus during its meeting from 6 to 10 April 1974, with representatives from one hundred and ten countries, declaring that this group is outside the fold of Islam and holds hostility towards Muslims.

Furthermore, various courts have issued rulings in the past regarding the Qadianis. In 1935, the Bahawalpur court made a decision, and in 1912, the sub-judge of Mungher banned them from entering Muslim mosques. Additionally, in 1974, the Supreme Court of the United Arab Emirates ordered the deportation of Qadianis, and in 1937, the Chief Justice of Mauritius declared that the Mirzais were non-Muslims. These legal judgments reinforce the understanding within the Muslim community regarding the non-Muslim status of the Qadiani group.

### Jamiat Ulama-i-Hind's Efforts Lead to Acquittal of Four Accused in Delhi Riots Case

New Delhi, May 25, 2023: In a significant development, four individuals accused of rioting and looting during the Delhi riots in 2020 were acquitted of all charges. Jamiat Ulama-i-Hind's unwavering commitment to pursue justice has played a pivotal role in this outcome. The organisation has been closely monitoring 261 trial cases related to the Delhi riots, with successful results emerging due to its diligent efforts.

During the court proceedings, out of two eyewitnesses, who were summoned to testify, one of them declined to give evidence, while the other witness admitted to being an eyewitness in an unrelated case, completely unrelated to the one being heard. Based on insufficient evidence against the accused, the court acquitted the accused individuals.

Among the acquitted individuals, Shahnawaz's case has been pursued legally by the Jamiatfor the past three years. Advocate Salim Malik, acting on the direction of President Jamiat Ulama-i-Hind Maulana MahmoodAsa'd Madani, represented the defense counsel. Due to the organisation's advocacy, these individuals were already granted bail, but they are currently facing another case under a separate FIR, in which Salim Malik is their defence counsel.

Maulana Niaz Ahmed Farooqui, member of the Legal Affairs Committee of Jamiat Ulamai-Hind, expressed his gratitude for the successful acquittal of the two.
