he Supreme Court on Monday, while hearing the petition of Maulana Mahmood Asa'd Madani, President of the Jamiat Umami-i-Hind regarding the continuous attack on the personality of the prophet (PBUH), issued notice to the central government and others to submit reports on the steps taken so far against this shameful act. The petition was being heard before a bench of Justice Ajay Manikrao Khanwilkar and Justice A S Oka. Advocate MR Shamshad appeared on behalf of the petitioner (Jamiat Ulama-i-Hind) The present Petitioners are approaching this Hon'ble Court with a prayer for issuance of appropriate directions in relation to the continuous attack on the personality of Prophet Mohammad (PBUH) and disparaging remarks by various persons in different parts of the country attacking the very belief system of the Muslim community at large.

It is submitted that insulting the Prophet Mohammed (PBUH) is akin to attacking the very foundation of Islam and in that sense is of an extremely grave nature as it results in not only the targeting of Muslim people but also in assailing the basis of their faith. It is further submitted that such speeches go beyond the limits of a permitted critical denial of another's beliefs, and are certainly likely to incite religious intolerance, and the State and Central Government authorities ought to consider the same to be incompatible with respect for the freedom of thought, conscience and religion and must take proportionate restrictive measures. It is also pointed out that such speeches destroy the secular fabric of our nation which also forms the part of the basic structure of our Constitution. Resultantly, the Respondents, being bound by the Constitution, ought to have an adversarial relationship with the proponents of such speeches and must take adequate remedial steps to prevent the same.

That the present Petitioners have approached this Hon'ble Court after waiting for a considerable amount of time by giving the State authorities to take appropriate steps of remedial as well as preventive nature. However it appears that the state authorities have completely failed in this regard. The Petitioners have also taken steps by lodging appropriate complaints before the Police authorities. Against many other communally sensitive speeches the Police has not at all registered an FIR and if the aggrieved persons have approached the Court of the Ld. Magistrate seeking appropriate directions for registration of FIRS, the Ld. Magistrate has dismissed the complaint under S. 156 (3) Cr.P.C. by taking cudgel of the principles laid down by this Hon'ble Court in different judgments.

Considering the entire facts it is necessary that this Hon'ble Court invokes its extraordinary jurisdiction by issuing appropriate directions fixing the accountability of the responsible persons placed within the system and also laying certain guidelines as to how the issue of hate speech and accused in recorded hate speeches are to be dealt with in a time bound manner. The Petitioners are making the above

submission being conscious of the fact that these hate speeches, specifically when it is made against the religious personalities like Prophet Mohammad (PBUH) and Muslim community at large, the diversity in the country and peaceful co-existence of the followers of different religious beliefs comes under serious threat. Protecting the diversity and peaceful co-existence of all citizens in India is the collective responsibility of the society at large including the authorities responsible for maintaining law and order in the country.

In view of the continuous attacks on the Muslim community at large, many violent acts have taken place in which many precious lives have been lost mostly of the people belonging to the weaker section of the society majority of them belonging to the Muslim community. In this background it is necessary that this Hon'ble Court considers appropriate directions in the line of prayer made in the present petition.

Reacting to the hearing in the Supreme Court regarding the desecration of the Holy Prophet (PBUH), the President of Jamiat Ulama-i-Hind Maulana Mahmood Madani said that no society in the world can remain civilized if any religious leaders are insulted by its member. The prophet of Islam Muhammad (peace be upon him) is a source of courage for human beings all over the world, Therefore, the perpetrators of such acts should be given exemplary punishment so that no one can dare to insult the leader of any religion.

5 Men Charged With UAPA Jamiat legal aid helped Abdussubhan to get acquittal

A Delhi court recently acquitted five persons accused of having connections with Lashkar-e-Taiba

while observing that mere recovery of the mobile phones and sim cards used to converse with a Pakistani number is not sufficient to prove conspiracy of terror plot.

Additional Sessions Judge Dharmendra Rana of the Patiala House Courts acquitted Mohd Shahid, Mohd Rashid, Ashabuddin, Abdul Subhan and Arshad Khan who were charged under sec. 120B Indian Penal Code & sec. 18, 18B and 20 Unlawful Activities (Prevention) Act.

While doing so, the Court observed thus:

"Mere recovery of the mobile phones and sim cards used to converse amongst each other or converse with a Pakistani number is not sufficient to prove the existence of any conspiracy."

" It is rightly pointed out by Ld. Defence counsel that there is nothing on record to establish that the abovesaid

Pakistani number belongs to the dreaded terrorist Javed Balluchi. IO Manishi Chandra (PW39) in his testimony has admitted that it is possible to collect the relevant information with respect to any Pakistani number, yet no explanation is forthcoming on record as to why no efforts were made by investigating agency to collect the particulars regarding the ownership of the mobile no."

Abdul Subhan and accused Ashabuddin @ Soukat (son of the sister of Abdul Subhan) had been arrested in the year 2001 by the CBI while carrying a consignment of RDX, AK56 rifles, and other arms in Santhalpur, Gujarat. Both were convicted in the said case.

After completing his sentence, Abdul Subhan came out of jail in the year 2010. In 2011, communal riots had taken place at Gopal Garh, District Bharatpur, Rajasthan where several persons belonging to a particular

community were killed. Abdul Subhan was a member of the banned terrorist organization, LashkareTaiba (LeT), and the said riots kindled his passion for Jehad.

As per the case of the prosecution, Abdul Subhan in order to give effect to his intentions to wage jihad came across Mohd. Rashid, stated to be a highly motivated person. Abdul Subhan convinced Mohd. Rashid to wage Jihad. Abdul Subhan had also tried to associate and motivate Javed and Sabbir who were residents of Mewat but they did not join him.

Abdul Subhan disclosed his plan to Mohd. Rashid about his intentions to kidnap a businessman for ransom to raise money for Jihad and that the money would be received in Dubai through hawala channels with the help of Javed Baluchi. He asked Mohd. Rashid to arrange for a mobile phone connection / SIM card on a fictitious

identity to talk to Javed Baluchi.

As per the case of the prosecution, Abdul Subhan in order to give effect to his intentions to wage jihad came across Mohd. Rashid stated to be a highly motivated person. Abdul Subhan convinced Mohd. Rashid to wage Jihad. Abdul Subhan had also tried to associate and motivate Javed and Sabbir who were residents of Mewat but they did not join him.

After perusing the evidence on record against the accused persons with respect to the alleged offense u/s 18 of UAPA, the Court noted that there are gaping holes in the prosecution version.

It was observed that except for the recovery of a few mobile phones and sim cards, intercepted conversations, and entry in the visitor's register in Kolkata Jail, there was no other incriminating piece of evidence sufficient in itself to establish the prosecution case, which seems to be based upon surmises and conjectures rather than any credible evidence.

Court also recorded that the prosecution has been unable to prove the identity of Javed Balluchi leaving aside the allegation that he is a dreaded terrorist.

It was observed that except for the bare contentions, there is nothing on record to establish the taint attempted to be attached with the credentials of Javed Balluchi. Leave aside the enquiry regarding the credentials of Javed

Balluchi, investigating agency seems to be not sure even about his real name and it emerges from the record that the prosecution refers Javed Balluchi as Javed Wadaich and Javed Chaudhary also.

I have no hesitation in observing that the investigating agency has made no efforts to establish the identity of obscured entity known by the name of Javed Balluchi and it is not even clear as to if some person by the name of Javed Balluchi actually exists in Pakistan or some mischievous person was acting under the fake identity."

The Court said that the call records at best only prove the fact that there was some conversation between Indian citizens on the one end and a person using a Pakistani mobile number on the other end, however, that by itself is not sufficient to presume that accused Javed Balluchi actually existed or that the accused persons conversing with him were involved in any conspiracy to commit any terrorist act or kidnap any rich businessman.

Furthermore, even if for the sake of arguments, the above said defects in the electronic evidence pertaining to the said intercepted conversation is ignored, even then the intercepted conversation is not sufficient to bring home the guilt against accused persons."

With regard to allegations of the five people being part of LeT, the court said that once the intercepted conversations available on record is discarded, there is no material available on record to connect accused persons with LeT.

In view of the above discussion, the Court did not find any merit in the case of the prosecution and acquitted the accused persons.

Khargone administration responsible for violence on Ram Navami procession; police acted in a highly partisan manner, Jamait Ulama-i-Hind delegation visits Khargone

New Delhi: May 10, 2022.

ccording to a high-level delegation of Jamiat Ulama-i-Hind that visited Khargone recently and held the local administration solely responsible for anti- Muslim violence in the state's Khargone town during Ram Navami procession.

The JUH delegation led by Maulana Hakeemuddin Qasmi, General Secretary of the outfit, underlined the fact that the local authorities allegedly breached every rule in the book. First, despite intelligence information, they allowed a rally to take place without permission. The gathering, which was supposed to leave Talab Chowk Masjid at 3 p.m., lasted until 5 p.m. with offensive songs being played in front of the mosque.

The delegation spoke with victims' families, reviewed relief efforts, and told them that the Jamiat will provide all possible assistance to anyone in need, regardless of faith or community. The

delegation paid special attention to the riot-affected regions of Mohan Talkies, Talab Chowk, Chhoti Mohan Talkies, Qazipura, Sanjay Nagar, Anand Nagar, and Khasas Wari.

The delegation also spoke with the family of Abrish Khan, who was killed in the violence. The death of Abrish Khan, the first casualty of the violence, was kept hidden from his family until

April 18, when the Police had found his body on April 11 itself.

The delegation met with the local collector and SP in particular, demanding an end to the imprisonment of innocent people. During the bulldozer operation, the Jamiat Ulama-i-Hind delegation claimed that there was prejudice between Hindu and Muslim shops.

The delegation pointed out that a clear distinction was maintained between Hindu and Muslim shopkeepers during the bulldozer operation. The hotel owned by a non-Muslim was let off while shops owned by Muslims were demolished which is both sad and embarrassing. In a similar operation, the police allegedly stormed Muslim homes and assaulted the ladies who were present. All of the dwellings and establishments demolished by the state after the Khargone incident belonged to Muslims.

In the presence of the police, miscreants set fire to Muslim places of worship and police remained meter spectators. For example, rioters set fire to a mosque near Mandi police station but no action was taken to stop them. The Jamiat Ulama-i-Hind firmly lodged all the complaints with the police administration and also shared their grief with Aleem Bhai, (the owner of the

Aleem Bhai whose hotel was destroyed in Khargone while two adjacent shops of Non-Muslims were left to stand



hotel whose hotel was destroyed and two adjacent shops belonging to Hindu communities were left) and said that the Jamiat Ulama-i-Hind would do its utmost to bring them to justice.

Similarly, there are 53 families whose houses were destroyed or looted by the rioters, but no bulldozers were used on the houses of those who did so by the police administration or local administration which shows utter discrimination.

Jamiat Ulama-i-Hind while expressing deep concern about this situation feels the need to take the following measures:

(1) According to the 267th report of the Law Commission that was published in 2017, a separate law should be enacted to specifically punish the instigators of violence and efforts should be made to ban any activity aimed at social and economic isolation of all minorities especially the Muslim minority.

- (2) In order to promote tolerance, peace and coexistence etc. among different faiths, 15th March as designated by the United Nations shall be observed as the day of Islamophobia every year. On this occasion a message of human dignity shall be disseminated across the world and display our common commitment for the eradication of all forms of racism and religious discrimination.
- (3) To address this situation, the Jamiat Ulama-i-Hind has set up a permanent department called the "Justice and Empowerment Initiative for Indian Muslims", with prime objective to develop an strategy for the establishment of peace and justice in the country.

However, the fact remains that this menace can not be tackled by establishing a single department. Rather it requires concerted efforts at every level. Therefore Jamiat Ulama-i-Hind urges all its units to be a part of this movement and to participate in its work with interest.

(7) Resolution over strengthening of the Sadbhavna Manch

Massed by the national governing body meeting held at Deoband on May 28,29, 2022

In accordance with the clause (8) of the Constitution of the Jamiat Ulama-i-Hind, which refers to "Social Services", it was decided in the session of the governing body committee of Jamiat Ulama-i-Hind held at September 12, 1919 to form "Jamiat Sadbhava Manch" which has at least eleven members. Half of its members will be non-Muslims. The forum will

include active members of the society and local leaders irrespective of religion and caste etc. The Forum shall convene a meeting every month to ensure the participation of the Non-Muslim brethren and will take under mentioned joint steps in accordance with the clause 8 of the Jamiat's constitution.

- (1) A joint gathering of people of different religious sects.
- (2) Strive for the fulfilment of civic

requirements.

- (3) To serve the workers, farmers and backward people.
- (4) Helping orphans widows and the oppressed section of the people.
 - (5) Collective efforts to prevent drugs and obscenity.
- (6) Finding peaceful solutions through mutual dialogue and discussion to sensitive religious issues such as use of loudspeakers in places of worship and use of public places for worship etc.
- (7) Collective efforts to protect environment through plantation, saving water and sanitation.

This session urges the leaders of Jamiat Ulama-i-Hind to strengthen this movement by forming Sadbhavna Committees in their respective areas.

Jamiat Ulama-i-Hind also announces on this occasion to organise more than one thousand Sadbhavna Sansad across the country to end the growing tide of hatred spread by the dharma Sansad and other groups. Representatives of every religions and caste shall be invited to participate in the Sadbhavna sansad.

Deoband: May 29: A two-day meeting of the governing body of Jamiat Ulama-i-Hind concluded today at Eidghah Maidan at Deoband. The meeting was chaired by Maulana Mahmood Asad Madani.

The last day saw a number of important resolutions including resolutions on UCC and Gayanvapi mosque and Mathura Eighth. A declaration was also issued in which all Muslims were advised to refrain from fear, despair and sentimentality and work for the betterment of their future.

Maulana Mahmood Asad Madani, President of Jamiat Ulama-i-Hind, in his last presidential address highlighted the importance of sacrifice for the motherland and said that even if our lives are lost for the protection of this country, it will be a matter of pride for us. He told when he spoke of the problems of Muslims, that had been criticized by some quarters. These are the forces who scare us but when we try to speak about them, they do not accept it.

He said in clear terms that we will continue to fulfil our responsibility to the country. If they do not like us to follow our religion, they do not deserve to stay in this country, they should migrate from this great land whose nature is unity in diversity.

"I say that this homeland is equally ours. And the majority of the country believes in idea of unity in diversity, so we are not going to settle in other country, if they are interested in dispatching us, let them go themselves.

On this occasion various great Islamic scholars including Maulana Arshad Madani, president JUH, Maulana Mufti Abul Qassim Nomani, Maulana Sufyan Qasmi waqf Darul Uloom Deoband, Maulana Hakeemuddin Qasmi, JUH General Secretary, Maulana Badruddin Ajmal also delivered speeches.

Jamiat resolution on Gayanvapi mosques expresses deep concern and disgust over the ugly attitude of forces hostile to the peace and tranquillity of the country as well as political parties patronizing them for repeatedly raking



up controversy regarding the old places of worship. Gyanvapi Mosque, Mathura Eidghah and other mosques are currently under such a hate campaign. This will result in disturbing the peace, order and integrity etc. of the country.

The Ayodhya issue has already severely damaged social harmony and the peaceful communal fabric of the country. Now, these conflicts will provide fresh impetus for further confrontation and the negative politics of majority domination. This session of Jamiat Ulama-i-Hind draws the attention of the ruling dispensation that reviving the differences of history will not be conducive to the peace and order of the country. The Supreme Court in its ruling about Babri Masjid has described the Worship Act as the basic spirit of the constitution of India. This decision of the Apex court explicitly conveys the message that the government, political parties and religious groups should keep away from reviving the controversial issues of the past. Only then it will redeem our pledges to the constitution, otherwise, it will be called great disloyalty to the constitution.

ON UCC, the Jamiat said that Muslim personal law such as marriage, divorce, khula, inheritance etc. are not framed by any society, individual or group etc. Nor are they parts of culture and customs etc. But they are essential parts of Islam like prayers, fasting and Hajj etc. derived from the Holy Qur'an and hadiths. Therefore, any change in the rules or regulations sanctioned by Islam or preventing anyone from following them is against the basic principles of Islam and sheer interference in the provision guaranteed in Article 25 of the Constitution of India. But the present government intends to abolish Muslim personal law by enacting a uniform civil code sidestepping the true spirit of the country's constitution.

This session of the Jamiat Ulama-i-Hind warns the Government of India that Muslims of the country cannot accept any change in Muslim Personal Law. Therefore, we demand that a clear ordinance be issued regarding the protection of Muslim personal law keeping in view the basic provisions of the Constitution of India. In other resolution, the Jamiat also demands stringent law to deal with issues of insult to the prophet and great personalities of any religion.


New Delhi: June 28, 2022:

Kanpur June 8, 2022: The high-level delegation of Jamiat Ulama-i-Hind met with the Kanpur district administration and police commissioner to lodge its protest against the one-sided arrest of Muslims and biased investigation.

It has been reported that two sides – Muslims and Hindus - clashed at the Chandeshwar Hatha on Friday, June 3, after evening prayers. The clash saw stone-pelting. Petrol bombs were also reportedly thrown. Several were injured.

This happened after a nongovernmental organization active for eight years, the MM Jauhar Fans Association, gave a call for shops to close so that a silent protest could be conducted against now axed Bharativa Janata Party spokesperson Nupur Sharma's comments against Prophet Mohammed PBUH on TV.

As the probe continues, the police have set up a Special Investigation Team, with four additional teams probing the case. Over 50 people have been arrested so far and FIRs have been filed against over 800 unnamed persons. The FIRs charge people with rioting, creating enmity and disturbing peace in the region. Police have also put up hoardings across town demanding the identification of 40 Muslim vouth in connection with the violence.

In one of the circulated videos, 20year-old student and labourer Hasib can caused great unrest in the entire nation.

He added that we do not support the miscreants and stone-throwers involved in any incident, but those who were



be seen being hauled up by police.

To assess all concerning issues, the National general secretary, Maulana Hakeemuddin Qasmi visited the city on Tuesday and called on the administration. In a separate meeting with Police Commissioner Vijay Singh Meena, Maulana Hakeemuddin Qasmi condemned the incident and expressed grave concern over the unilateral arrests. Maulana said that the unilateral action in the wake of the riots in Kanpur has arrested have no previous criminal records and thus they should not be treated as accustomed criminals.

Rains continue to batter Gujarat, Telangana Jamiat units lead flood relief and rescue operation

New Delhi 15 July:

eavy rains in several areas of Gujarat over the last few days brought life to a standstill. While residents of low-lying areas have been shifted to safer places, those stranded at home due to waterlogging have been provided with relief material. Due to a flood in the Purna River, almost all parts of Navsari city are covered in floodwaters. Thousands of people are trapped in their houses with no food and water. Their belongings were washed away.

In this critical hour, Jamiat Ulama-i-Hind under the leadership of its president Maulana Mahmood Madani is providing relief materials. The Jamiat units are engaged on a war footing in providing relief and rescue in the flood-affected areas of Gujarat and Telangana.

Jamiat Ulama Gujarat General Secretary Prof. Nisar Ahmed Ansari and State Secretary Aslam Bhai Qureshi have written in their report dispatched to JUH national headquarter in New Delhi that providing basic amenities to the needy persons has become a challenge in itself because it is not easy to reach out the people. Despite this, the Jamiat local units are actively engaged in providing financial support and food and shelter to the people. A joint Jamiat team from Jamiat Ulama Navsari, Valsad, and Vapi conducted 'Operation Bachao', in the area where water has entered houses, they were able to relocate people and arrange immediate food at the camp.



To make this process more dynamic, Jamiat Ulama Navsari has temporarily converted a house into an office and started a concrete relief plan. So far 500 kits and 2000 water bottles have been distributed. 7000 water bottles, 1000 food packets, 200 kits, 200 plastic bags and 500 milk bags have been distributed in Valsad and Navsari by Jamiat Ulama Vapi. Jamiat Ulama Valsad distributed 100 Satranjis, 100 sheets, 200 Biscuit Packets in Kashmiri Nagar. Jamiat Ulama Vadodra has distributed 500 Kits, 100 Sheets, 100 Pillows in Bodoli, but these are only initial services, their

support is still needed continuously. Therefore, a delegation of Jamiat Ulema Gujrat consisting of Professor Nisar Ahmed Ansari, Aslam Bhai Qureshi and Mufti Imran etc. will visit the affected areas tomorrow and try to expand the relief work.

Similarly, Telangana's Hyderabad city and surrounding districts including Nizamabad, Adilabad, Bhinsa Waqarabad, Asifabad, etc are suffering from the flood. Jamiat Ulama under the leadership of Hafiz Peer Shabbir is providing there Food and drinking materials on a war footing.
