Will safeguard madrasa at any cost: Jamiat Ulama-i-Hind

UP govt. attempt to survey madrasa smacks of evil intention

Jamiat's 'protect Madaris' conference at Delhi witnesses' presence of 200 UP madarsa rectors

New Delhi, Sept 6, 2022:

he largest socio-religious group, Jamiat Ulama-i-Hind, declared on Tuesday that they will defend Islamic seminaries at all costs, and described the Uttar Pradesh government's forthcoming survey of madrassas as a malicious attempt to disparage the madrasa education system. It also announced the opening of a helpline for madrassas that encounter any issues and constituted a steering committee to look into the matter.

The UP government's announcement to examine "unrecognised" madrassas prompted Jamiat Ulama-i-Hind to call a meeting of madrasa rectors to assess its implications. More than 200 madrasa representatives, including those from prestigious seminaries like Darul Uloom at Deoband, Darul Uloom Nadwatul Ulama, Lucknow, Mazahir Uloom, Saharanpur, and others, attended the meeting under the banner of "protecting Madrassas". They denounced the UP government's attempt to demonise the madrasa, saying it is the country's greatest asset which played a pivotal role in the liberation movement of the country and made immeasurable sacrifices.

The UP government on Wednesday announced a survey of unrecognized madrassas in the state to gather information about the number of teachers, curriculum, and basic facilities available there, among others. The 12-point survey questionnaire that would be used by the UP government was discussed at the meeting. A PowerPoint presentation gave a thorough explanation of the purpose and scope of the survey. In the discussion, it was agreed that the madrasa system's laws and regulations needed internal revision.

The meeting also raises concerns about the government's retrograde mindset, which by adopting a combative approach causes confusion and fear among the populace and builds a barrier of mistrust between (Contined on next page)

the communities. This government's behaviour is completely unacceptable. Governments ought to shun this sort of conduct. It pointed out that because madrassas have played a significant historical role in the country and have consistently made sacrifices for it. Even today, madrassas continue to benefit the country by educating youngsters from disadvantaged backgrounds and advancing efforts to achieve national literacy rates of 100 percent. Madrassa graduates become sincere and patriotic citizens of the country.

Actually, it is malicious to call that madrasas are not adhering to the government system. It is essential to respond with a reasonable approach. Maulana Mahmood Asa'd Madani, the meeting's organiser and the president of Jamiat Ulama-i-Hind, voiced these views while addressing the conference. Madrasas, according to Maulana Mahmood Madani, are very beneficial. This system, which was provided to us by our elders, is unparalleled worldwide, so it will be safeguar-ded at all costs. He told the media that a steering committee has been formed for further action.

- (3) Madrassas ought to begin offering modern education through NIOS or other agencies.

our Madrassas survive. Although we have always making an effort to ensure that our religious institutions operate in peace, harmony and cooperation, the divisive forces seek to eliminate us and something we won't ever permit. He asserted that the existence of Madrasas is necessary for the country's survival, not for its opposition. Its 1200 year old history attests to the fact that this is where the country has always been built.



According to Mufti Abul Qasim Nomani, rector of Darul Uloom Deoband, we should think about improving the internal structure of the madrassa system, particularly the structure connected to Dar al-Iqama, (hostel), etc. However, one must be cautious of the oppressor's intentions.

The rector of Darul Uloom Waqf Deoband, Maulana Muhammad Sufyan Qasmi, stated that the 100-year history of Jamiat Ulama-i-Hind is proof that it has consistently guided both the country and the community. We anticipate that the Jamiat will guide madrassas in this turbulent phase. He also suggested creating a helpline for this purpose.

Maulana Atiq Ahmad Bastavi, representing the Nazeem-e-Ala of Darul Uloom Nadwatul Ulama, Maulana Syed Muhammad Rabi Hasni Nadvi, argued that the survey's questionnaire purpose was a mischief rather than reform. Therefore, a suitable response should be prepared to this new evil of communal forces. In this context, he suggested approaching the government representatives.

Jamiat Day Care hospital opens in Sholapur

amiat Ulama-i-Hind (JUH) established a hospital in Sholapur, Maharashtra, to provide care for the underprivileged and disadvantaged segments of society. Jamiat-e-Ulama Day-Care Hospital, which opened to patients in late July of this year, strives to make health services affordable for the underprivileged and needy. Several distinguished physicians and activists attended the hospital's inauguration function, which was presided over by Maharashtra State President of JUH Maulana Nadeem Siddique.

Regardless of caste, religion, or faith, Maulana Nadeem promised in his speech that "the hospital will provide quality treatment to the needy patients at a very reasonable charge."

The hospital's medical director, Dr. Farooque Mulla, told TwoCircles.net that the daycare facilities would soon start operating as well as the OPD (outpatients department) and a medical supply store.

In addition to an OPD, according to Dr. Farooque, the facility also

offers all kinds of blood tests at discounts ranging from 30 to 50%. For major cases, specialised doctors also come to see us.

JUH Sholapur District President Maulana Ibrahim Qasmi stated that "health and education are essential facilities which should be supplied

free of cost or lowest fees but regrettably these two have become a lucrative business" when considering the necessity to construct such a healthcare centre for the underprivileged.

We started this hospital on a 5000 sq.ft area "considering the need of the hour," he remarked. The hospital's mission, according to Maulana Ibrahim, is to "serve the underprivileged," and we are focusing all of our resources on the health and education sectors. Our new project will involve offering workshops to help kids from underrepresented populations get ready for competitive exams," he stated.

The hospital's infrastructural costs were covered by donations from the public. "We raised money for all of this by asking individuals for donations. I must

highlights that the Biradaris of Muslim society in our city have given generously donated for construction of the hospital, said Hasib Nadaf, general secretary of the JUH. According to Nadaf, JUH established a Covid-19 Care centre at the same location during the epidemic. This brand-new multi-specialty hospital is our ideal undertaking, he declared. Salahuddin Peerzade, a social activist, praised JUH for this project. In all humanitarian efforts, JUH always takes the initiative. Everyone needs to step forward and assist them in realizing the Jamiat's projects, he said.

Ashfaque Baghban, a young political and social activist, said that the city is in desperate need of specialized hospitals, particularly for women. "I routinely get calls from women who complain about being mistreated in government hospitals. Poor patients always struggle to get the healthcare they need, he said. Baghban continued by expressing his desire that the JUH's newly established hospital will feature a fully functional gynecology section.

Suspended Telangana BJP MLA held again under PDA following **Jamiat's several FIRs**

New Delhi, August 26, 2022:

he arrest of Raja Singh, a ■ Telangana BJP legislator who has been suspended over controversial remarks purportedly directed at the Prophet Mohammad, was hailed by Jamiat Ulama-i-Hind on Thursday as a "necessary measure," adding that the country will not pardon anyone who commits blasphemy.

On Thursday morning, Singh was detained by the Hyderabad police under the Preventive Detention Act (PDA), days after being granted bail in the blasphemy case that lead to protest against his release.

Maulana Mahmood Madani, the president of the Jamiat, observed that the Preventive Detention Act is a law that the police employ to hold "notorious and dangerous" prisoners in jail for a year.

According to a statement released by the Muslim organization, the Jamiat district units in Telangana met with their respective district authorities at 12 locations and presented a memorandum requesting the arrest of the offender under the PDA.

Eight other FIRs were also filed against Singh at various police stations, according to the statement.

Singh's arrest, according to Madani, was a "necessary action" for maintaining law and order, and such violators cannot be granted asylum in a nation with a diversity of religious beliefs.

Those who insult religion will not be pardoned by the country, he declared.

At Jantar Mantar, a number of organisations, including the National Council of Dalit Christians, Jamiat Ulama-i-Hind, the Catholic Bishop Conference of India, the National Council of Church of India, and others, participated in a joint protest against Article 341's discriminatory nature as Christians and Muslims from scheduled castes were deprived of affirmative schemes for SCs. Based on injustice and prejudice, the then-president of India passed an ordinance to this effect in 1950. Additionally, it is against the Constitution's spirit. Later, the Sikh and Buddhist were included in the scope of this Article's provisions, but Dalit Muslims and Christians were not.

Everyone, who took part in the demonstration categorically demanded the elimination of discrimination as well as the implementation of the Justice Ranganath Mishra Commission's recommendations. The general secretary of Jamiat Ulama-i-Hind, Maulana Hakeemuddin Qasmi, stated that it has been a long-standing demand of the organisation for Dalit Muslims and Christians to also be covered by this constitutional provision. resident of the native village of Bilkis Bano, where she was gangraped and her 16 family members killed in 2002, claimed that several Muslim families have left the village out of fear following the release of 11 convicts in the Bano case.

The villagers told the Jamiat delegation, "We are afraid; several individuals have left the village out of fear of violence from the side of the convicts after their release. We have asked the collector to put the convicts behind bars and offer safety to the villagers".

Under the leadership of Maulana Hakeemuddin Qasmi, a high-level Jamiat Ulama-i-Hind delegation travelled to Rahimabad Colony Baria, where they visited the terrified residents and offered help. Many central, state, and district officials were part of the Jamiat group, who met with Dahod ADM and spoke with him about the situation. The Jamiat delegation asked for safety to the Muslims of Randhekpur on this occasion so they may go back to their homes and do business. The perpetrators of the most heinous crimes connected to the Bilkis Bano case have been let to live in freedom. It hurts and is a stain on the civilised society's forehead.

It is regrettable that Bilkis Bano and her

family members were not taken into confidence in the remission decision of her tormentors. The Jamiat delegation also went to Randhekpur village to assess the situation.

In this meeting, major decisions on limited companies, the use of interest income for GST, and "health insurance" were made after extensive discussion. In addition to this, a recommendation was also made regarding the country's present anti-Islamic climate.

More than 200 scholars from all over the country, including representatives from Darul Uloom Deoband, Darul Uloom Nadwatul Ulama, Lucknow, Jamia Qasmia Shahi in Moradabad, Mazahir Uloom, Saharanpur, and other renowned institutions in South India, participated in this conference and presented their papers.

Going beyond its agenda, the Islamic scholars passed a resolution on the current anti-Islamic environment in the country. The resolution reads:"It becomes clear that systematic efforts are being made against Islam and Muslim identity at the national level. And to make them effective, media and social media are used as tools

tools in t h e hands of anti- Islamic forces. This gathering of Jamiat Ulama-i-Hind strongly condemns all such attempts. It expects the media channels to show their interest in issues that are related to the development of

the country. Programs containing anti-Islamic false statements augment communalism which is very harmful to the progress of the country.

This gathering appeals to Muslims not to be influenced by these blasphemous programs being run on the media and social media and to approach the religious scholars for religious guidance. However, if offensive content is broadcast on any channel or at the platform of social media, take legal action and lodge an FIR against channels and platforms."

During the deliberations on the medical insurance issue, the conference unanimously adopted a resolution stating that Islamic Sharia allows for the needy to receive medical insurance coverage if they are afraid of incurring unaffordable costs in the light of the current domestic and international realities. It is preferable to arrange with the insurance provider that in exchange for the annual premium, the provider will do a medical examination at least once per year; in this scenario, usage of a health insurance policy is also permitted.

In an important proposal regarding the use of GST interest money, it was decided that if the GST amount given is directly or



indirectly payable to the government and is not anticipated to be returned to the consumer or dealer, then the GST payment may be made using the GST interest money. And if the retailer receives the designated value in the name of GST from the customer (buyer), they must inform the government of this sum. It is improper to have the shoppers conceal it.

In the other suggestion addressing the limited company, it was found that a limited company is in theory equivalent to Mudharabat (a term used legally in Islamic sharia), so long as its primary operation does not involve gambling, interest, or the trafficking of haram items. It is legal to create this type of business, participate in it, work there, and benefit from it. If such a limited company goes bankrupt, the responsible parties must sell their movable and immovable property and assets to pay off their debts and other arrears. Even after that, if there is any outstanding liability and

if the responsible parties were negligent or careless, the payment will still be required.

Apart from resolutions, a few significant sermons were also delivered by some great Islamic scholars, including Maulana Rahmatullah Kashmiri, Mufti Muhammad Rashid Azmi, Mufti Atiq Ahmad Bastavi, and Mufti Salman Mansoorpuri (president of Jamiat Ulama-i-Hind and Maulana Mahmood Madani, respectively). Other notable Islamic scholars who attended the meeting as special guests included Maulana Sagheer Ahmed Khan Rashadi, Mufti Shoaibullah Khan Miftahi Bangalore, Maulana Maqsood Imran Bangalore, Maulana Mahmood Hasan Khairwa, Maulana Zaheer Bangladesh, and Maulana Yasir Nadeem America. amiat Ulama-i- Hind President Maulana Mahmood Asa'd Madani sent Chief Minister Yogi Adityanath a letter in response to the local government's unilateral action to the incidence of violence in Ibrahimpur, Sultanpur district of Uttar Pradesh. He has urged the CM to stop the unilateral action and take concrete steps to bring about peace in the area. It is noted that on the day of the Durga immersion, some antisocial people placed the idol close to the mosque in Ibrahimpur and then they began playing loud DJ music. The responsible members of the mosque asked to proceed after Namaz, but no one paid attention to their request.


The argument then descended into violence. The mosque suffered damage. In Ibrahimpur, Muslim stores and a madrassa were vandalised. In addition to this, the madrasa's students were also physically assaulted.

But at the moment, only Muslims are being arbitrarily detained by the police. The viral footage is now in the public domain. Instead of enforcing justice, the SO Amarinder Singh incited the crowd while yelling, "We will punish them selectively" and "Will burn their homes". Everything the police officer stated in the video is now being put into action. Four of the five individuals including the madrasa who received the notice for illegal occupation are Muslims, while the fifth is a member of the Yadav community. All of the individuals arrested thus far are Muslims who were also assaulted by lawyers today within the court premises.

While this was going on, a delegation from Jamiat Ulama-e-Hind, led by Maulana Mutahirul Islam, president of the Jamiat Ulama Sultanpur unit, met with the District Police Commissioner and a police captain and delivered a memorandum to them questioning the unilateral action.

In the letter, it was requested that the police officers be kindly instructed to prevent any further acts of violence and that meetings of Aman committees and common peace yatras be taken out in order to restore peace and tranquility. (3) Act against the rioters in a fair and proportionate manner without taking into

Jahangirpuri violence accused

Noor Alam gets bail

New Delhi, October 19, 2022:

The accused in the Jahangirpuri Delhi communal clashes, Noor Alam, has been granted bail thanks to the legal action taken by Jamiat Ulama Hind. Sheikh Inamul Haq was also granted bail as a result of Jamiat's efforts earlier in the month. Judge Satish Kumar carefully considered the legal representations of Muhammad Abdul Ghaffar, Muhammad Noorullah, and Muhammad Sartaj in the case of Noor Alam. They argued that the accused had nothing to do with the alleged crime and that the local police had only detained the defendant in order to resolve their own case. He was identified in a FIR and is currently being held since April 17, 2022. Now that the accused's case has been thoroughly investigated, bail should be granted. The state-appointed attorney, however, vehemently contested the defendants'

After hearing the arguments of the parties, the court said that the investigation of the accused has already been completed and the charge sheet has also been filed; now it will take a long time to complete the trial. At the same time, keeping the accused in judicial custody will not serve any purpose. Some of the co-accused have been granted bail by the High Court of Delhi and some have been granted bail by this Court. Therefore, the petitioner/accused Noor Alam is granted bail on a bond of Rs. 25,000/-.

In light of these happenings, Chief Minister Yogi Adityanath was urged to take swift action against the perpetrators in a letter written last week by Maulana Mahmood Asa'd Madani, president of Jamiat Ulama-i-Hind to him. Following that a Jamiat delegation headed by Maulana Hakeemuddin Qasmi travelled to Sultanpur and spoke with Ibrahimpur's victims. On this occasion, the president of Jamiat Ulama-i-Hind received a letter from the rector of Jamia Mustafa Qadriya and the people of Walipur asking him to take up the cases and seek justice on their behalf.

We support the Ibrahimpur citizens' demand, and we will provide legal representation for any innocent people who have been imprisoned. (Insha Allah).

Capacity Building cum Workshop

on Islamophobia

Nine members of the Jamiat local unit from Loni and Hapur participated in the workshop. Following a brief introduction of our organisation, Dr. Azhar Ali asked Maulana Hakeemuddin Qasmi sb, General Secretary of Jamiat Ulema-i-Hind, to provide an overview of the current situation of Indian Muslims in India and the atrocities Muslims have been subjected to in our country by citing recent instances of prejudice, physical assault, verbal abuse, and police atrocities committed against Muslims due to their identity.

he Jamiat Ulema-i-Hind Youth Club office in New Delhi hosted a capacity building training workshop on "Understanding Islamophobia and Hate Crime in India" on September 30, 2022. The workshop's main objective was to educate the attendees on the rising numbers of Islamophobia and hate crimes committed against Muslims in India.

Nine members of the Jamiat local unit from Loni and Hapur participated in the workshop. Following a brief introduction of our organisation, Dr. Azhar Ali asked Maulana Hakeemuddin Qasmi sb, General Secretary of Jamiat Ulema-i-Hind, to provide an overview of the current situation of Indian Muslims in India and the atrocities Muslims have been subjected to in our country by citing recent instances of prejudice, physical assault, verbal abuse, and police atrocities committed against Muslims due to their identity. He also informed them about Jamiat's regular legal actions it takes, if necessary, in extreme cases of hate crime. He then handed the programme over to Dr. Azhar Ali, who continued the workshop by providing a lengthy, practical, and interactive presentation on "What is Islamophobia" in general and in the context of



India in particular. He began by outlining the fundamental principles of how Islamophobia works. He noted that Islamophobia has many different manifestations, including verbal and physical abuse, hate speech against individuals, stigmatising, and demonising. By

using examples of how radicals try to frighten you, diminish your religious identity, and challenge your religious practises and eating habits, he has effectively contextualised the crucial subject of Islamophobia. Two recent incidents have been given. One describes how radical Hindutva group in Shahjahanpur, Uttar Pradesh, harassed and assaulted a party of Muslims travelling from West Bengal to Ajmer Shareef, Jaipur, Rajasthan. Second was a discussion of the recent violence created by Hindu Right-Wing individuals in Leicester to educate them on what Islamophobia is and how it operates.

Dr. Azhar Ali also enlightened them about the fundamental rights, the Right to Equality, Right to Freedom, Right to Freedom of Religion and Religious Practices, under the Constitution of India. He continues by saying that everyone in this country, especially Muslims, must be aware of these fundamental rights as well as their obligations to other nations and fellow citizens. Why this matters: According to him, you have the right to file a lawsuit against anyone responsible for any discrimination, physical abuse, or assault based solely on your religion, no matter where it occurs. Knowing about these constitutional rights gives one power and inspires others to strive for justice at the same time. He asked Mashhood Alam, Research Associate for the project Justice and Empowerment Initiative for Indian Muslims (JEIM), to introduce the project and its functions, as well as what are the aims and objectives and how we report and document cases of Islamophobia, following this informative session on understanding Islamophobia in the Indian context. What are the aims and objectives, and how do us report and document cases of Islamophobia and Hate Crime against Muslims.

Mashhood Alam started his presentation by providing a brief history of Muslims in India and how they contributed significantly to the development of the country. But he made note of the fact that over the past several years, Muslims in India have been the target of various Islamophobic attacks. Jamiat Ulemai-Hind created a division called "Justice and Empowerment Initiative for Indian Muslims (JEIM)" in 2021 as a result of these atrocities

committed against Muslims. Its main goals are to combat hate crimes, defend human rights, and offer victims of hate crimes legal and, if necessary, financial aid. We have a committed team under the JEIM that works both locally and remotely to report and record instances of

hate crimes and take appropriate action.

JEIM has three core functions; 1) Reporting the hate crimes, 2) Advocacy the victims, and 3) Documentation of Cases. We also have a Case Review Committee (CRC) in which core CRC members decide which case should be documented and which case should be rejected based on the nature and category of the case. Category here refers to various categories that have been conceived under this project. These are;

- 1. Acts of Hate'
- 2. Acts of violence
- 3. Attacks on the religious places
- 4. Police atrocities
- 5. Discrimination, Exclusion, prejudice and other forms.

Mashhood Alam also shared with them the Bulletin on Islamophobia published by Jamiat quarterly in which these cases are documented. Finally, at the end of the session, he told the participants the purpose of this training workshop and told them how they would contribute to providing information related to incidents of Islamophobia. These participants promised they will create a group and will also try connecting local journalists, activists, and lawyers at the local level and include them in the group. Two groups were created; 1) Hapur Working Group and 2) Loni Working Group. These groups are tasked to verify the case, if possible, get the report from the local police station, help the victims and finally send the document to the head office for further documentation.
